(Includes: 2 pp reports, 1 report to the court and filing fee for adoption papers in county of residence for the readoption) Report to the court without other services is \$500. For additional children adopted at the same time, the readoption fee will be \$2000 (2 children) or \$2500 (3 children)	
** Please note, if a family has an Attorney file for the adoption and IAG only completes the report to the court (without other services) and any documents must be resubmitted to the court, IAG charges an hourly rate of \$50.00 to complete these documents. **

(Individual birth mother counseling \$50 per hour additional court process/forms and ICPC)	
If IAG is named on the 100A and or 100B ICPC forms fees apply	\$1,000
Amendment to the homestudy	\$250 (if IAG did the HS)
Updated home study	\$700 (if IAG did the HS) \$900 (if HS by other agency)
***Amendment is for a one page change in the study such as address, job, income, change of Country adoption plans, age, sex, race of child to be adopted etc. If the study is older than 3 months and needs to be sent to CIS you will need a complete update. Or an update is needed if the study is over 12 months old. New supporting documents are needed for an update.**	
Additional adoption consulting or family counseling	\$50 per hour
Birth parent relinquishments	\$1,200 plus mileage
Additional documents for Eastern European Counties	\$200
Additional documents and contracts if requested by placing agency (examples would be Hague supervised provider documents etc.)	\$200

**Additional Fees:**

- Mileage is billed at a rate of \$.55 per mile plus drive time at \$15 per hour. No mileage is charged for Gaston or Mecklenburg County residents.
- If there is any additional homestudies or document requested after the homestudy process is completed, the charge is \$25 per hour. State certifications \$10 plus the cost of 2 FedEx bills @ \$20 each and postage to mail these to you or your agency.

***Please inform your homestudy worker if you have additional documents you will need for your adoption such as post placement guarantee, extra agency license etc. We like to do documents all at the same time to save you money so please ask your placing agency if there are any additional documents required by your homestudy agency. If these documents are not done at the time of the homestudy or post placement report additional fees will apply. If the agency is required to sign a post placement interagency agreement, then the post placement fees are due at the time of signing the interagency agreement.***
